2. **Sri.N.Jagan Mohan, Office Superintendent:** The objection received through email after 5 PM of 28-4-2025, thereby technically it is not valid to take into consideration, however, it is to submit that, the Applicant seniority from the date of absorption i.e from 03.05.1993 against the supernumerary post in the cadre of Junior Assistant is rejected in as much as per Para 6 (c) of G.O.Ms.No.77, Ind, & Comm, Dept., Dated:26-02-2009 The applicant entitled only from the date of absorption against the regular vacancy in the cadre of Junior Assistant that to placing the applicant name below the regular Junior Assistants



who are working on the date of applicant absorption against regular vacancies as Junior Assistant. The provision of Para 6(d) G.O.Ms.No.77, Ind, & Comm, Dept., Dated:26-02-2009 speaks about the tests if any to be passed for consideration of absorption against the posts in this office as on 3-5-1993, but not speaks about the further promotion after absorption.

Accordingly, the seniority of applicant was fixed below the last regular candidate in each year based on their seniority and also based on the availability of substantive vacancies, with consideration given to the vacancies that arose after 1993 onwards. Hence there are merits in the plea of the applicant, Moreover, the applicant has already approached the Hon'ble Court and the Hon'ble High Court has passed orders in the WA No.35 of 2024 and the same has been disposed by finalized the seniority of the applicant in the cadre of Junior Assistant, hence his request for placing below Smt.C.Madhavi Latha and above, Smt.G.Laxmi Anuradha is treated as negative.
