Where any difficulty arises in applying this sub-rule seniority shall be determined by the government, if they are the appointing authority and in other cases, the authority next higher to the appointing authority shall determine the seniority, request not feasible and hence deferred.

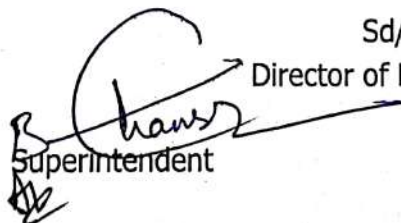
