Memo.No.19447 /H1/2011 Dated: 30-1-2012 and he should be treated as Junior Assistant only after adjustment against the substantive vacancy which were arised due to promotion of Smt.Hari Kala and other vacancies. Accordingly, the applicant should be treated as Junior Assistant on substantive basis from the year 2012 though his services treated as Junior Assistant from 03-05-1993. It is further submitted that, mere designating the applicant as Junior Assistant from 3-5-1993 as per the impugned memo will not give any right to claim for notional promotion, until unless his services absorbed in the substantive vacancy of Junior Assistant, hence, the notional seniority awarded by this office is itself has to be re-examined in light of the instructions contained in the sub-clauses of the para 6 of the GO Ms.No.77, Industries & Commerce (IFR.II) Department, Dt: 26-02-2009.

Prema Kumar, Office Superintendent, O/o MHSRB, TG, Hyderabad <u>OBJECTION:</u> Requested place his name in the year 1993 vacancies only, after the last candidate already appointed in the cadre of Jr. Assistant as on 03-05-1993 consequently place his name in each cadre of seniority lists i.e. Sr.Assistants, Office	It is to submit that the applicant seniority from the date of absorption i.e., from 03-05-1993 against the supernumerary post in the cadre of Junior Assistant is rejected in as much as per Para 6(c) of G.O.Ms.No.77, Industries & Commerce (IFR.II) Department, Dated: 26-02-2009. The applicant entitled only from the date of absorption against the regular vacancy in the cadre of Junior Assistant that to placing the applicant name below the regular Junior Assistants who are working on the date of applicant absorption against regular vacancies as

Superintendents and to issue him further promotion to the Administrative Officer on par with his juniors who were appointed after 03-05-1993 and do the justice in view of the Government orders and as well as Court orders

Junior Assistant. The provision of Para 6(d) G.O.Ms.No.77, Industries & Commerce (IFR.II) Department, Dt. 26-02-2009 speaks about the tests if any to be passed for consideration of absorption against the posts in this office as on 03-05-1993, but not speaks about the further promotion after absorption.

Accordingly, the seniority of applicant was fixed below the last regular candidate in each year based on their seniority and also based on the availability of substantive vacancies, with consideration given to the vacancies that arised after 1993 onwards. Hence, there are no merits in the plea of the applicant. Moreover, the applicant has already approached the Hon'ble Court and the Hon'ble High Court has passed orders in the WA No.35 of 2024 and the same has been disposed by finalizing the seniority of the applicant in the cadre of Junior Assistant. Hence, his request is negated.

Hence, his request is negated.

Keeping in view of the above, the objections of the above individuals are disposed and there is no change in the orders of the seniority fixed in the Provisional Inter – Se – Seniority list of Office Superintendents of HOD and State Level Institutions vide reference 1st cited.
